



Important Notice: Product Discontinuation – Discontinuation of 3M Structural Adhesives and Primer Products

Dear Valued Customer,

As a follow-up to prior communications, 3M is notifying you of the following:

- 3M is discontinuing the following list of 3M Structural Adhesive and Primer Products (see table below)
- The impacted products and potential alternatives, if applicable, are identified in the table below.

These are necessary changes in connection with 3M's announcement in December 2022 that it will exit all per- and polyfluoroalkyl substance (PFAS) manufacturing and work to discontinue the use of PFAS across our product portfolio by the end of 2025. This decision is based on careful consideration and a thorough evaluation of the evolving external landscape, including multiple factors such as accelerating regulatory trends and changing stakeholder expectations.

Please note that 3M remains committed to the development and launch of next-generation structural adhesive films as alternatives to 3M[™] Scotch-Weld[™] Structural Adhesive Films AF 163-2/-3, AF 191, and AF 3109-2. Additionally, 3M is on track to complete its reformulation of 3M[™] Scotch-Weld[™] Structural Adhesives EC-2615 B/A, EC-2615 B/A Charcoal, EC-3333 B/A, and EC-7202 B/A by the end of 2025. Updates regarding these programs will be subject to separate communications.

If you would like to place further orders for the discontinued product(s) (supply of which is not guaranteed), such orders must be submitted by the 'Last Order Submission Date' shown in the table above. 3M reserves the right to limit orders to historical levels of demand. Order requests will generally be considered and/or filled on a first come-first served basis. All orders are subject to material availability.

Other General Information

Please be aware that availability of a prior formulation and/or discontinued product may be limited, and 3M cannot speculate about the availability or prevalence of products utilizing prior formulations in the supply chain. Orders receiving a 3M order confirmation ("Order Confirmation") with an estimated delivery date will be considered as accepted by 3M. Delivery dates are estimates only and are subject to change. Other communications, such as an order acknowledgement or an Order Confirmation with an "In Review" statement, does not constitute acceptance of an order by 3M.

Unless otherwise stated in writing by 3M, you may cancel or modify an order only with 3M's advance written consent.

In the event a 3M product is proven not to conform with 3M's applicable product specifications, then, to the maximum extent permitted by law, 3M's entire liability and customer's exclusive remedy will be at 3M's option either: (i) repair or replacement of the non-conforming product with a conforming product; or (ii) refund of the purchase price paid by customer for each non-conforming product, within a reasonable time after written notification of said non-conformance and return of the affected product to 3M. 3M shall not under any circumstances be liable for direct, indirect, incidental, special, or consequential damages (including but not limited to loss of profits, revenue, or business) related to or arising out of this letter or the referenced product(s), including the use, misuse, or inability to use such product(s).
