



Raw Material Changes for Epocast® 938-A2

Dear Valued Customer,

This letter serves as a follow-up to our previous communication (*ANL-US_2023-124-LA_938-A2_12.18.2023*) dated December 18, 2023.

The replacement product, **EPOCAST® 938-A3**, has been approved and qualified to the new BMS specification, **BMS5-21**, with a material classification of Type 1, Class 1. As a result, the product will no longer be available in the **BMS5-28 Type 12, Class 1 & 2 & Type 13** specification and will instead be offered in **BMS5-21 Type 1, Class 1** specification.

The new SKUs for **Epocast® 938-A3** are now available for purchase and shipment. There are no known regulatory limitations associated with the new formulation.
